## **Arthington Show is Celebrating it's 102<sup>nd</sup> Show - 2019**

### **Arthington Show – Sunday 30<sup>th</sup> June 2019**

The Society is now accepting applications for Trade/Craft Stands at the 2019 Arthington Show to be held on the large showground in Pool-in-Wharfedale, near Otley, Leeds, LS21 2QA.

#### **Trade/Craft Stands Outside**

Fees will be chargeable at £12 per metre **frontage**. All Tradestands have a depth of 9m to allow for parking one car at the rear of the stand. Please take into consideration all space needed for guy ropes and access needed for the public. **The minimum frontage size will be 3m.** 6ft Trestle tables will be charged at £7 each and folding chairs £2 each.

#### **Trade/Craft Stands Inside Marquee**

Fees will be chargeable at £50 for one allotted space to accommodate one 6ft trestle table. Please take into consideration all space needed for displays and access needed for the public. 6ft Trestle tables will be charged at £7 each and folding chairs £2 each.

**Please Note: On the Morning of the Show Tradestands are advised to arrive & be set up by 9.30am. The Tradestand Organiser will be on the show field from 6am. The show opens its gates to the public at 10am. Please make sure your stand is in line with the pegs to help keep the walkways clear for the general public.**

The following conditions are listed for your help and information:-

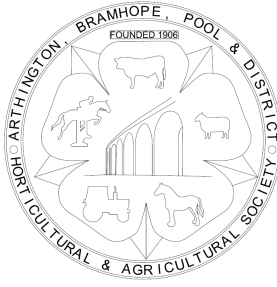
1. The Society reserves the right to refuse any application received without any reason being given.
2. Exhibitors must not sublet any portion of the space allotted to them without prior consent, in writing, from the Trade Stand Organiser.
3. No auctioneering, lotteries or microphones will be allowed.
4. Electricity is not available on the Showground.
5. Access to the Showground on the Saturday evening before Show Day can be arranged. The Society will not accept any responsibility for units left on the Showground overnight.
6. Exhibitors are requested to take into consideration all ground space needed for public access around their stand when giving measurements. Please allow for guy ropes, caravan draw-bars, etc.
7. Any Exhibitor wishing to sell refreshments must first of all contact the Trade Stand Organiser to see if this is permissible.
8. No applications accepted after 24th June 2019.

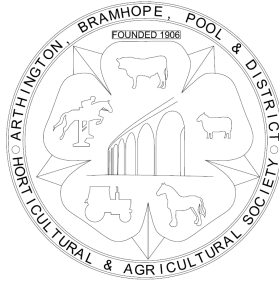

## Guidance on the Preparation of a Risk Assessment by Trade Stands

A Risk Assessment is put together to show that you have considered what could go wrong, and if appropriate have taken steps to reduce the risk of it happening and/or have a plan on how to respond if the worst happens. The more things on your list, the more it shows you have thought things through.

So the first job is to list potential Hazards. Consider:

- Does your stand contain any potentially Hazardous items? (Hazardous either to the Public OR your staff/helpers). Such as:
  1. Hot/Cold surfaces
  2. Sharp items (Knives, axes, saws etc.)
  3. Animals (that may bite, pass on fleas, cause allergic reactions etc.)
  4. Possible poisons (inhaled dust etc.)
  5. Machinery (even non-working), which could trap limbs or clothing.
  6. Electricity (including batteries)
  
- Could people in or around your stand slip and/or trip?
  1. On wet grass
  2. Over guy ropes
  3. Uneven ground (rabbit holes)
  
- Could unexpected weather cause problems?
  1. Blow the stand or part of it onto people
  2. Rain collecting on the roof
  3. Excess Heat or Cold.
  4. Too crowded because of people sheltering
  
- Does your stand have unusual problems because of:
  1. Too near trees
  2. Direct Sunlight.
  3. Too steep a slope(Or any other similar problem of which the organisers should be aware).
  
- How would you respond if an animal (Horse, cow, sheep, hen, ferret etc.) escaped and hid in your stand?
  
- How would you respond if a customer had a medical emergency (Diabetic fit, Heart Attack etc.)?

Making this list is the most important aspect. Next people usually allocate a “frequency” score and a “Seriousness” score to each hazard. The ‘frequency’ could be:

1. Happens at least every couple of shows.
2. Often happens once every few years
3. Never been known to happen to me.

And ‘seriousness’ could be:

1. Death or serious injury
2. First Aid case
3. Inconvenience.

You then multiply ‘frequency’ by ‘seriousness’ to give a figure for ‘Risk’. You then make a decision that (for instance) everything with a ‘Risk’ factor of 4 or less will be looked at with a view of risk reduction and above 4 will be regarded as not requiring action at the moment.

Remember that the Show does have qualified paramedics on duty on the showground, but you shouldn’t be relying on them or your Public Liability Insurance to get you out of any trouble.
